Dear Sierra Saver Member:

It is time to renew your Sierra Saver Ambulance Subscription!

The Sierra Saver Program is a tremendous value. As a subscriber, you and family members residing with you are covered in the event an East Fork Fire District ambulance transport is needed. Your subscription is also reciprocal with neighboring fire agencies that offer ambulance subscription programs. These agencies include: Carson City, Storey County and Central Lyon County. So, if you require an ambulance transport in these jurisdictions, your East Fork Sierra Saver Subscription is good there too! Please note that you will not receive a Sierra Saver Membership card however your subscription information will be saved in our database.

The East Fork Fire District continues to partner with Care Flight. For just \$30 per year you and your household can be part of the Care Flight membership program. As a Flight Plan Member, should you or anyone in your household require medically necessary Care Flight services, your membership will cover deductibles, co-pays, and any out-of-pocket expense not covered by your medical insurance. If you don't have medical insurance your bill will automatically be discounted by 20%. If you are an existing member of the Care Flight program, a renewal notice will automatically be generated and mailed to you. Be sure to let them know you are a Sierra Saver member for the discounted price.

To renew as an East Fork Fire Sierra Saver member, simply complete and return the enclosed Sierra Saver Application and Ambulance Subscription Program Agreement, along with your payment to the East Fork Fire Protection District by **December 31, 2017**. All payments received prior to December 31, 2017 will apply toward an enrollment period of January 1, 2018 through December 31, 2018. Payments received after December 31, 2017 will apply toward an enrollment period which will start the date we receive your payment and end on December 31, 2018.
